Exhibitor Information

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct Test. Dogs completing a title on Saturday or Sunday trial 1 may move up for Saturday or Sunday trial 2 and Sunday (if title completed on Saturday). This is up to the handler and not required. Move-ups between trials need to be done as soon as the class is over and until ½ hour after the conclusion of the Trial for move-ups between days. Move-up forms will be available at the Secretary's table. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$35 fee for all returned checks. No entries will be taken over the phone or electronically. Make check payable to CCDTC. Send entries & fees to the trial secretary. Dogs must have a Barn Hunt registration number.

Dogs must be leashed or crated when not working. There is indoor crating available. Please make sure your crate is safe and secure as the dogs may be highly excited. Soft crates are **NOT** recommended

Electronic collars and/or devices or flexi leads are not allowed in the building. Approved collars include flat snap or buckle of solid construction and leather or nylon leads. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed.

Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced. Dogs may **NOT** be brought to the gate in any disallowed collars, prong collars, or on a Flexi lead. Dogs MUST run "naked", i.e. without collar/harness.

Dogs will be run in height order from Small to Large with dogs being handled by the same person separated into differently staged groups.

Refunds are available for injured, deceased dogs. Notification must be made to the test chairman/secretary within 30 minutes before the start of the test.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Bitches in season are required to run in panties and remain in panties unless outside in the separate potty area. Entry fees for bitches that come into season will be refunded if you decide not to run your dog. Please contact the trial secretary. If bringing a bitch in season, you must inform the trial secretary prior to

the trial and inform all exhibitors at the judge's briefing.

It is suggested that exhibitors bring their own chairs. Please bring mats to put under metal crates and chairs. Food will be available on site (continental breakfast and lunch will be available, donations requested) and there are numerous fast food restaurants within 3 miles

If you think that you will earn a major title during this trial, please let the secretary know so that we can be prepared with awards. ☺
