Sell out of your vehicle in designated outdoor space on side of building: \$5.00 a day per vehicle  
10x10 outdoor space in grass area: \$5.00 a day.

**You will be charged a \$5.00 fee that is refundable upon request after your space is emptied.**

Each vendor is responsible for their own space, tables or display materials.

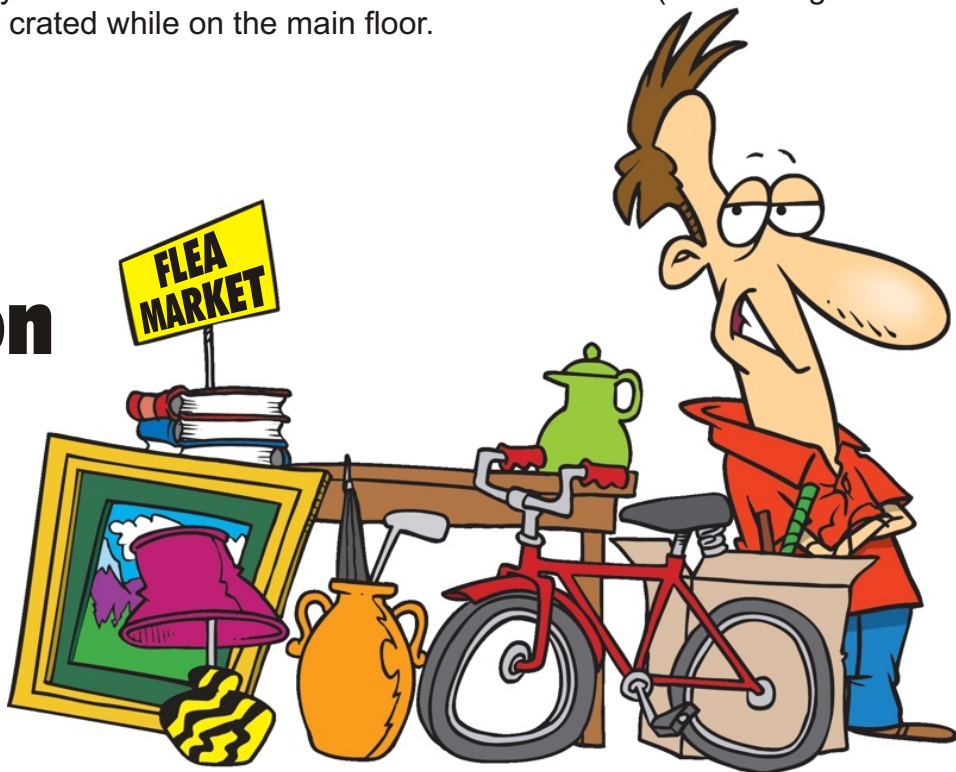
