It is expressly understood that each attendee is responsible for the behavior of their dogs and/or children and that only the dog being tested may be within 20' of the test area. Any attendee whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made. K9SD and the trial host and their agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors attendees, or to any of their dogs or property and further assumes no responsibility for injury to children. The trial host reserves the right to decline entries for cause and may remove any dog, handler or spectator as specified in the rules. No one shall have any recourse or claim against K9SD, the trial host or any official thereof.

DIRECTIONS

CCDTC is located in Miami Township on Route 50 just east of I-275. Our address is 6058 Kells Lane, Milford, OH 45150. Take the Route 50/Hillsboro exit off of I-275 turn towards Route 50/Hillsboro (not towards Milford Parkway) and turn right (east) on Route 50. Travel approximately 2 ½ miles through three traffic lights. After the third traffic light (Round Bottom Road, UDF on corner) turn left on the second street, Kells Lane,

just past Sugar Camp. Our building is the second building on the right. The property adjoins Cincinnati Riding for the Handicapped.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold K9 Scent Detection (K9SD), the event-giving club, their members, directors, governors, officers, agents, superintendents and event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any K9SD approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
